RE: NOTICE OF BASIC ASSESSMENT PROCESS FOR THE PROPOSED DEVIATION OF THE ESKOM JUNO-GROMIS 400kV TRANSMISSION POWERLINE, WITHIN THE NORTHERN CAPE AND WESTERN CAPE PROVINCES OF SOUTH AFRICA

Notice is hereby given in terms of regulation 41 (2) of the Environmental Impact Assessment Regulations of December 2014, published in terms of Chapter 5 of the National Environmental Management Act, 1998 (Act No. 107 of 1998) in line with the application for Environmental Authorisation for the aforementioned project.

This letter serves to inform you that Eskom Holdings SOC Limited proposes to deviate sections of the 273km Juno-Gromis 400kV Transmission line corridor which was authorised by the then Department of Environmental Affairs and Tourism on 6<sup>th</sup> November 2007 with a reference number 12/12/20/720. The proposed project triggers listed activities under Government Notices R. 983 Activity 12 (xii) (a) (c) and R.985 Activity 14 (a) (xii) (ii) (aa), (cc), (ff), (hh) and (f) (xii) (ii) (aa), (cc), (ff) and (hh).

Sections of the proposed deviations will encroach on identified Critical Biodiversity Areas and will traverse various farm portions as indicated on the Table below:
